## 1. course conditions

1. all course components (modules) are conducted according to PADI standards. The course instructor (m/f) is responsible for the presentation of the contents.
  2. for the participation in diving activities a medical certificate is only required if at least one of the health questions (separate form) has to be answered with "yes".
- Irrespective of this, a diving medical examination prior to the diving course is expressly recommended by us.
3. the DiveCenter Stuttgart is entitled to make decisions regarding the start and end times of the course.
  4. the course instructor (m/f) is entitled to exclude from the course participants who disturb the course permanently or hinder other course participants or persons who do not meet the course requirements.
  5. mask and snorkel are not included in the course price.
  6. additional services during the course, such as trips to the lake, parking costs, lake fees, hotel reservations or similar are not part of this contract. They are neither subject to the obligations of DiveCenter Stuttgart nor is any liability assumed for them. Additional services to the course are separate and liable to pay costs.
  7. the punctual appearance is the responsibility of the course participant.
  8. registered and fixed theory, pool and open water appointments must be cancelled 48 hours before the start of the appointment by the course participant, otherwise an additional fee of 25 euros will be charged. (Exception to this are illnesses or injuries that make diving impossible, with presentation of a medical certificate).
- Trial courses can be cancelled free of charge up to 48 hours before the start of the course. In case of later cancellation or no-show, the entire course price will be charged.
9. before pool and open water dives the packing and loading as well as after pool and open water dives the unloading and hanging up of the rental equipment are part of the course. In case of non-participation an additional fee of 10 Euro will be charged.
  10. the participant agrees that he can be photographed during the diving course. These photographs may be used free of charge in the context of marketing (including on the Internet and social networks) of the DiveCenter Stuttgart. This consent can be revoked in writing at any time.

11. failure to meet PADI performance requirements will result in non-certification.

12. your data will be deleted when it is clear from the circumstances that your request or the matter in question has been conclusively clarified.

However, if a contract is concluded, the data required under commercial and tax law will be retained by us for the periods specified by law, i.e. regularly for ten years. 13. registered office and place of jurisdiction of the company "DiveCenter Stuttgart" is Stuttgart.

## 2. terms of payment:

1. the course fee is to be paid in cash or by bank transfer at the latest by the beginning of the course without further request.

2. in case of non-attendance of a course without written cancellation, the undersigned has to pay the full cost of the course.

3. it is up to the goodwill of the DiveCenter Stuttgart, in case of cancellation of a course, to credit the course price in form of a credit note for another course date. However, this requires immediate payment of the entire course price.

## 3. refund conditions:

1. the registration fee is generally not refundable.

2. cancellations are possible e.g. for health reasons and require proof by a medical certificate. Cancellations must always be made in writing. In case of cancellation with a medical certificate up to

3 weeks before the start of the course, any course fees paid will be refunded in full, with the exception of the registration fee.

4. in case of cancellation with a medical certificate up to 2 weeks before the beginning of the course, 60% of the course fees will be refunded, except for the registration fee. In case of cancellation with a medical certificate 1-13 days before the beginning of the course, 30% of the course fees will be refunded, with the exception of the registration fee. In cases of cancellation where the student has not yet paid the course fee, DiveCenter Stuttgart is generally entitled to the outstanding amounts, minus the above agreed refunds.

5. after the beginning of the course a refund, also partial refund of the course fee is excluded.

6. if a student interrupts a diving course for health reasons that make diving impossible (diving medical certificate), the missing course contents can be made up within 6 months free of charge.

If the last course unit is longer than 6 months ago, a skill review must be completed before continuing the course. The cost of this is borne by the student.

If the last course unit was more than 12 months ago, the course must be started again from the beginning, at the student's expense.

Before continuing the course, the student must present a diving medical certificate, which certifies the diving ability.
